


## **SOUTHERN ALUMINUM ALULITE FOLDING TABLES SOLICITATION FOR BIDS**

 Clean with mild soapy water and rinse thoroughly. For dirtier tables, clean with Windex®, Top Job®, Formula 409®, or Mr. Clean®. Non-abrasive household cleaners can be used on stains. If stains persist, make paste of baking soda and Windex and rub into stain. Rinse thoroughly with water.
